Report of the WORKSHOP n. 1.1: "Ideation and Visualization" Deliverable DT1.2.3 of the project ENES-CE, Municipality of Forlì (IT)

On the 14th of February 2020 was held the 1st Workshop meeting of scheduled in the frame of the project ENES-CE. The Municipality of Forlì through its in-house society FMI s.r.l. organized the event to fulfil the objective proposed within the project. During the previous period was selected a professional figure to help planning the participating path and moderating the meetings.

The event saw the participation of several environmental associations active on the territory of Forli involved to start the process of the revision of the SEAP through the phase of "Ideation and Visualization".

During the meeting, after a round of presentation of the participants and an icebreaker activity everyone exposed his or her point of view on the environmental conditions of the country and in particular of Forli, highlighting the most critic points.

The FMI staff presented the ENES-CE project aims and activity and referred about the status-quo analysis of the SEAP to the audience and together were read the main actions described.

The representative of the Municipality of Forli greeted the bystanders and the whole process of revision of the SEAP.

Among the opportunities related to the project ENES-CE and included in the process of revision of the SEAP was approved to develop a participative path involving further stakeholders (technical, industrial, commercial, social, etc.) and to meet also more than during the next two workshops scheduled by the WPT1 project Work Package: that would help in finding shared opinions to be used writing the new SECAP.

Besides the revision of the SEAP activity, was presented the issue of the consumers' purchasing group, which will be the pilot action defined for the Municipality of Forlì, a first round of ideas led to think to which device or equipment could better fit the energy efficiency purpose of the project.

At the end of the worktable the audience was led to reflect on which stakeholder could be invited to join the process from the next step.

In conclusion, were defined the next steps of the participative path of revising the SEAP and writing the SECAP, and assumed that at the end of the process will be summarized all the shared contributions and published on the institutional website.
