

## Report of the WORKSHOP n. 3: "Presentation of the new energy plans to the wider public" Deliverable DT1.2.7 of the project ENES-CE, Municipality of Forlì (IT)

On the 8<sup>th</sup> of June and on the 30<sup>th</sup> of June 2021 was held the 3<sup>rd</sup> Workshop meeting in the frame of the project ENES-CE. The Municipality of Forlì through its in-house society FMI s.r.l. organized the event to fulfil the objective proposed within the project. The event took place in two sessions: the first one with the stakeholders participating to the path for the revision process from SEAP to SECAP in the form of webmeeting; the second meeting was a public event held in presence in a green area inside of one of the city parks. A professional communicator in the field of environmental sustainability, Michele Dotti, moderated the two sessions of the meeting and during the evening of the 2<sup>nd</sup> July, he also performed for the audience an acting show of his from the stage.

### I Session - Workshop 3.1 08th of June 2021

Both the stakeholder groups (economical/institutional and environmental associations) gathered together on an online web-videoconference, where with the help of Michele Dotti, a professional moderator have been analysed the different impacts expected to be fostered by the SECAP in terms of tackling the Risks and Vulnerability connected to the climate changes for the territory of the Municipality of Forlì.

The FMI s.r.l. staff presented the goals set for the SECAP of the Municipality of Forlì and the set of data collected in order to define and reach them. Furthermore, the energy consumption values of the public buildings and services of the Municipality of Forlì have been displayed.

Some issues about the organization of the public event to the wider public have been discussed: the chosen green area in a park of Forlì, the presentation of the ENES-CE pilot action connected with the establishment of the Energy Consumer Group and the distribution of the 100 energy efficiency kits, Michele Dotti's performance about environmental sustainability and its communicative impact and appeal to the wider public.

Concerning the pilot action and the equipment composing the energy saving kit (DT3.3.1), it will include the following devices:

- A Thermo-Hygrometer and air quality indicator;
- A Power and energy plug-in measurement device;
- A Luxmeter;
- A solar toy;
- A solar and dynamo flashlight/radio/battery charger;
- A design LED lamp.

During the roundtable with the stakeholders, many observations renewed the interest in the participative path and remarked the importance of the role of the Administration in giving examples and offering a guidance to the citizens and the importance of connect the different plans in order to harmonize all the actions as part of a whole consistent general plan. A strong accent was put on the importance of the communication of what is done and planned also to give the opportunity to transfer a planning document into an operational one.





### II Session - Workshop 3.2 30th of June 2021

In the field of the Municipal green area "Via Dragoni Park", took place the event of presentation of the activities for the revision of the SECAP. During the evening, the Assessor for the Environment Mr. Petetta welcomed the citizens and presented the activities of the path from the existing SEAP to the new SECAP, underlined the involvement of the local institutional, economic and environmental Stakeholders and highlighted the focus group dedicated to the students of the primary schools, which led to the production of two important communicative videos containing their point of view about the Energy and Environmental Issues of the SECAP.

The presence of the children and their families allowed the FMI Staff to present the Energy Consumer Group foreseen by the ENES-CE WPT3 Pilot Project to a sensitised audience and it was possible to register several people in the Energy Consumer Group; to any subscriber an energy saving kit was booked and made available for the distribution at the FMI Offices from the subsequent week.

Mr. Claudio Maltoni, the Director of FMI srl, the in-house society in charge of the SECAP revision stated the importance of the involvement of the whole community, together with the Administration in sharing and aiming towards the Covenant of Mayors' goals.

The communicator and actor Michele Dotti, who moderated every previous workshops of the path, presented the whole evening, illustrated the energy saving kit at disposal for the members of the Energy Consumer Group made up by the equipment to measure and reduce the use of energy at home and offered a theatrical monologue about the engagement into the environmental struggle towards a sustainable energy and the fight against climate changes.
