1. Transnational Web Meeting minutes

1.1. Transnational Web Meeting with Representatives of the Associates (D.T4.4.2)

30 January 2020

- 10.00 Beginning of the meeting
- 10.00 Official beginning of the meeting. Mr. Marco Braga (LP t2i) welcomed all the partner members, explained the organizational things; Elisa Bertoni (PP02 REGVEN) explained the procedure of the meeting and invited all partners to make a brief Introduction of the Meeting.
- 10.30 Eliane Fernandes Ferreira and Prof. Dr. Gertraud Koch (PP08 UHAM) started the presentation of the set the criteria to define the most promising dimension of ICH's valorization projects. see PPT for contents.
- 11.20 Eliane Fernandes Ferreira explained the organisation of the local events to present the set of criteria and the reports that need to be written about the tailored events.
- 11.20 Marco Braga opened the discussion to all partners. All ARTISTIC Partners did attend the web meeting and gave their comments on the presentation of the set of criteria.
 - Dieter Heider asked UHAM to send the Powerpoint Presentation per email.
 - Marco Braga commented on the presentation and discussed the importance of staying connected to the partners, respecting their local aspect and reality. He spoke also about the importance of building trust between all stakeholders and how to encompass politicians and politics into ICH projects and its real values. We need to keep in mind to achieve that politicians and politics work in service of ICH valorization and local development and not against it.
 - Marco Braga commented also that innovation is at the core of the discussion and there is a lack of mind-set. Museums need to find a way to work about ICH, being modern and creative, turning it not into an object or issue of the past, but of the present and the future.
 - Elisa Bertoni (PP02) mentioned that it is important to harmonize all existing ICH initiatives in their regions. Many times, they do not know about each other. Coming together and networking the ICH projects will achieve much more. In addition, there is the necessity of efficient networking to improve the impact of ICH in the regions. Despite it all, the governments or politics should work to support and promote the ICH projects that contribute a lot to economic development in the regions. Elisa added that there is the necessity to reduce political decisions that are contraproductive to ICH initiatives. Moreover, there is the need of physical spaces where all partners can grow and practice the exchange of knowledge and activities. For instance, many festivals are not stable enough or happen in a sustainable way. The knowledge and experience exchange between youth and elders is crucial. In addition, education plays a key role in the safeguarding of ICH and empowering of ICH initiatives, including the extension of ICH projects, training and exchange between all parts of society.
 - Daniela Adler and her associate mentioned that they will have an event in May 2020 that will involve local politicians. It is going to happen in a very important cultural Market of their region. Daniela mentioned that the issue "networking" plays a key role in the importance of working with ICH initiatives. In addition, there must happen an "open up" between ICH initiatives and all groups of society. In her opinion, there is the necessity to observe culture a bit broader and it is



importance to support the exchange between all generations in a very interactive way, with for instance, interactive events.

- Aradszki Zsombor (PP06) mentioned that there is the need to rethink actuality and the past and the need to many times rethink what ICH is all about. We shall not freeze energies. There is the necessity to invite people from all levels to work with culture, with ICH.
- Dieter Heider (PP07) mentioned that he agrees with the point that it is important to make ICH visible and known to the wide public. It is also crucial to understand and see ICH in its specific contexts. In addition, it is good to observe the Sustainable Development Goals (SDGs) and compare how ICH in the specific regions contributes to it.
- RARR (PP09) mentioned that the presentation was very precious. It will support them in their work with stakeholders. RARR appreciates the underlining of the approach to preserve ICH, albeit being innovative.
- Jan Vaclav (PP12) mentioned that it is important to observe all financing possibilities, such as national programs that can help to support ICH initiatives. There are financing tools on regional and national level that need to be taken into account by the different partners. There is also the necessity to innovate the market and the relationship with the public, bringing together ICH with all parts of society.
- JHK (PP11), ISN (PP13), BOVEC (PP05) and Jarina (PP04) were thankful for the presentation and had anything else to add.
