

How to reach the Venue:

Arriving by train:

- From Milano Centrale railway station: Metro line n.2 (green line) to stop "Garibaldi F.S.", change to Metro Line n.5 (lilac line) and move to "Milano Domodossola"; Federchimica is two minutes walking distance from Milano Domodossola (please see the map).



Arriving by plane:

- From Malpensa Airport: take "Malpensa Express" train to Milano Cadorna; from Cadorna F.N. take the train to Milano Domodossola; Federchimica is two minutes walk from Milano Domodossola (please see the map).
- From Linate Airport: take the bus to "Milano Centrale" railway station; subway from "Milano Centrale" Metro line n.2 (green line) to "Garibaldi F.S.", change to Metro Line n.5 (lilac line) and move to Milano Domodossola; Federchimica is two minutes walk from Milano Domodossola (please see the map).
