# 2. Establishment of the stakeholders' group

For the creation of the working group we decided to proceed first through bilateral meetings and talks; this to immediately understand the interest of the identified potential stakeholders. Once sufficient feedbacks were collected, a meeting was organized with those who were deemed most promising and potentially more able to make a significant contribution during the continuation of the project.

This first presentation meeting took place on December 11th, at the Salone del Popolo in Palazzo d'Aronco (the room was made available by the Municipality of Udine, one of the project partners). The only organization invited that could not be present due to commitments already made was the Regione Friuli Venezia Giulia. In any case, the Region confirmed its interest and was informed of what was said and decided during this meeting. Within this session, the CITYCIRCLE project was presented in depth. The stakeholders expressed very positive feedbacks, which underlined the very strong interest of the created





working group. In addition to this, they were also offered an introduction to the concepts of circular economy (with a Focus on the overall aspects of the CE and its innovation potential, as foreseen by deliverable D.T2.2.2).

Finally, the next steps to be pursued have been programmed with stakeholders, such as the two workshops foreseen by deliverable D.T1.2.11 and the creation of a shared strategy on the circular economy (D.T.1.2.8).
