Summary description of the implemented training measure(s), explaining the specific goal(s) and target groups

Public Institution for the Development of the Međimurje County REDEA, together with PP9, MENEA, organized second training seminar for their stakeholders. The second training was held on June 5<sup>th</sup> 2020. The main goal for organizing such an event was to educate as many as possible participants, especially, representatives of public bodies so that they can transfer their knowledge to other interested stakeholders. Information generated through calculator can be used as basic knowledge for the suitability of the installation of RES measures on public/private buildings.

An invitation for training was sent primarily to members of Local Support Groups who has been involved and informed about value calculator from the beginning of the project. Since at the first training seminar we didn't have many town representatives, at this meeting we primarily aimed at inviting them. In total there were 14 participants from different target groups.

As the situation with COVID-19 is much better in Croatia, we organized this meeting in person.

At the training, project partners mentioned how project consortium established value calculator and also his features. Since, among the participants were decision makers and public representatives, we explained to them what benefits and added value can they expect from the calculator if they decide for RES measures. To cover all areas in energy efficiency, we went through value calculator tool and shoved all its' functionalities.





#### NUTS region(s) where training(s) have been conducted (relevant NUTS level)

This training was organized in person. PP13 and PP9 organized second training at Technology-Innovation Centre Međimurje, Bana Josipa Jelačića 22b, which correspond to NUTS3 region: HR046, Međimurska županija.

# Expected impact and benefits of the trainings for the concerned territories and target groups

Second training seminar that was held on June, 6th 2020., was important primarily for local decision makers and other general public, because this was an opportunity for them to suggest a specific RES measure or general proposal that they would like for us to analyzed it. Due to that, they were able to get first-hand information from project partners about possible RES measures, and also they saw how to use value calculator. The biggest benefits that every interested stakeholder can get from value calculator are specific information, examples of good practice and possible RES measures at one place, due to the associated characteristics of individual building.

## Sustainability of the training(s) and developed training material(s) and their transferability to other territories and stakeholders

Within this project, we as project partners can assure sustainability of trainings through the whole period of the project duration. After the project end, we won't organize any more training, but the one thing that we can be sure regarding sustainability is that every participant has our contact information to feel free to ask us anything about value calculator. We'll inform our target groups every time we have some news about project RURES in total, not just value calculator.

Our target group members were selected specifically because they were representatives of municipalities, towns and regions, representatives of public services and so on. So we can be sure that our participants will transfer their knowledge gained through training seminars to other stakeholders and territories.

At this training seminar we personally helped our stakeholders so that they can try value calculator on their own at their laptop. So we think that at that way we can be sure that they will be able to transfer their knowledge to other territories and stakeholders.

Lessons learned from the development and implementation of training measures and added value of transnational cooperation

The one lesson that we can learn from the development and implementation of training is that no matter the situation, there is always some way to transfer knowledge to others.
