2. ACTION PLAN CONTENT AND STRUCTURE WITHIN SALUTE4CE



Action Planning Steps Description of each step				
General considerations	-Background and aims of the SALUTE4CE Project. -Description of action plan goals: How will urban acupuncture be utilized within the respective FUA?			
Creating local action plans (3-phase process)	Problem statement - potential acupuncture points Potential solution (s)- pinpricks /needles			
Step 1:Preparation Phase (preliminary activities)	 -Deciding on responsible parties (e.g. forming an action planning team) -Developing visions for city/ FUAs and identifying goals -Gaining support for the pilot project (e.g. public, political & financial) -Defining planning procedures (e.g. Set milestones, work program, timetable) 			
Step 2: Analysis Phase (gather information, evaluation)	-Data collection & generation if necessary -Creation of a FUA profile (i.e. knowledge concerning general conditions and the local situation) -Pre-selection of UEA sites			
Step 3: Development Phase (formation of action plan)	-Final selection of UEA sites -Defining plan targets and measures -Public feedback on planning process and concept to improve the action plan (i.e. living labs)			
Plan Implementation	-UEA site creation -Maintenance & management plan creation -Monitoring & evaluation concepts based on set indicators

Proposed structure of a local Action Plan

1. Introduction

Challenges of urban development in the City XYZ; context of SALUTE4CE; context of urban green and UEA; general objective of the plan

2. Process of action planning in the city XYZ

Initial situation, vision and goals of the city, Involvement of stakeholders, citizen participation, work program and timetable

3. UEA sites in the city

Selection of UEA sites, analyses, assessment matrix

4. Action plan

Identification of measures and approaches, public feedback, selection of targeted measures, recommendations for the future

5. Maintenance and management plan

Who will take over maintenance, future financing, etc.

6. Controlling, Outlook and future prospects

Report on action planning

ightarrow Action planning goals

- Action planning goals vary for each FUA, but
- All 4 FUAs focus on climate change adaptation (heat regulation, air quality, high precipitation events).

\rightarrow Main supporters throughout planning process

- Variety of actors involved: e.g. city employees, garden/greenery offices, city planning offices, office managers, consultants, students
- Main supporters: consultants, NGO's, political/local administrators, climate protection managers, green/city urban planning departments, external experts, local residents, scientific SALUTE4CE PP



TAKING COOPERATION FORWARD

3. ACTION PLAN HIGHLIGHTS IN PARTICIPATING CITIES

- ightarrow Public Involvement in the planning process
- All focused on including the public (in GI planning, future maintenance).

\rightarrow Selection of UEA sites

- Importance of the public emphasized (involved in planning process in various formats: living labs, GIS map applications, presentations, online meetings, research walks).
- Data contributing to selection
 - collected from residents, cadastral (e.g. land use, climate change) and
 - information collected on-site (e.g. soil, percentage of sealed area, shade, temperature)
- \rightarrow Controlling and monitoring (C&M)
- Included measuring for example: temperature, biodiversity, impact of green sites on learning capacity, impact of vegetation/soils, vitality of green areas, visual usefulness of furniture, safety, accessibility

Advice from Project Partners

Alessandria

• The planning process can be improved through private intervention/ contribution and by multi-annual planning carried out by administration.

Chorzów

• The first step in improving the planning process for UEA is to convince decision-makers that such investments are important and necessary.

Impuls Region

 To move UEA from status of a model approach to a regular task, a widespread network of well-integrated stakeholders is needed to support and sustain the process.

Liptovský Mikuláš

• The list of UEA sites should be a living document and should be updated/supplemented regularly.
