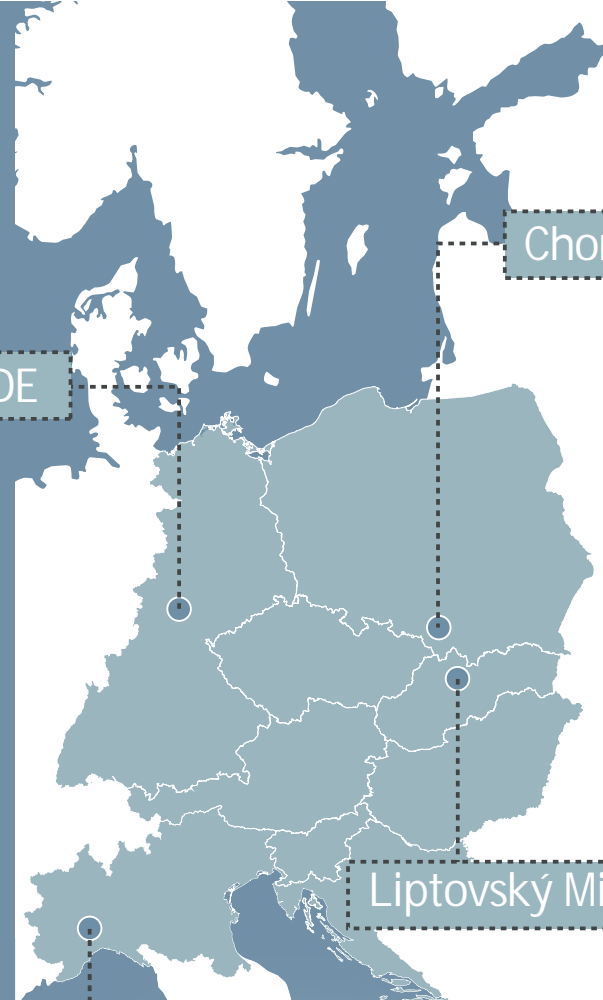

**GRÜNZUG SCHÜTZENHOFSTRASSE**  
 The investment area in Jena should be created to a green corridor. The main point are climatic reasons but also to give the residents the opportunity to get out of the city into the countryside in an attractive way. The area in Jena was selected because there are not enough usable green spaces for the northern urban area.

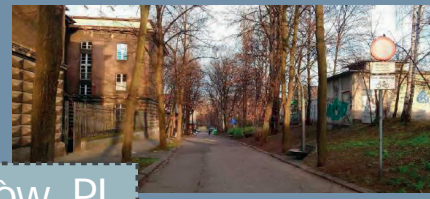

**VIA TERESA MICHEL**  
 The spot is a rectangular grass-grown area, leveled in the middle and featured by a perimetrical ditch, 2000 m<sup>2</sup> large. On the south side the area is delimited by a foot-way planted with trees, and by the extension of the urban cemetery of Alessandria. The project's goal is the realization of the "City's green lung" through the plantation of native forest trees with thermo-regulation and depurative functions. It could be included also tools for outdoor sports.

**A GREEN STREET - BANKOWA STREET**  
 There must be more grass which fills the gaps between concrete slabs in grassy pavement. It would also be reasonable to include an absorbent basin, which slows down the water flow, enables infiltration into groundwater and acts as a rainwater pollution filter, perfectly working along roads, squares and parking. Water can be supplied through the street inlet system or directly from the sidewalks.

**ZÁKLADNÁ ŠKOLA ARBORETUM**  
 The area on which the design of "grandfather's grandmother's orchard" is solved is part of the premises of the Primary School with a kindergarten in Demánovská Street in the Palúdzka district. The school wants to integrate the territory into its educational activities for children of kindergarten as well as pupils of the first and second level of the school. Removing the fence between the vegetable garden and the area in question will allow them to be interconnected and thus increase their use.



## 3<sup>rd</sup> Project Meeting

The third project meeting took place in „the clouds“ on 28-29 May 2020. The COVID-19 pandemic made the meeting a tele-conference, but this not stopped SALUTE4CE team's effort for looking for a better, green, healthy and sustainable future.

Representatives of all the 10 partners have attended, starting their common work with the introduction of Anna Starzewska-Sikorska, SALUTE4CE project coordinator, who resumed the second semester outcomes and presented challenges and deadlines for the third semester.

WP leaders presented the development of the other work packages, outlining some common difficulties in physical meetings and the organization of events. Nevertheless, the pandemic situation did not affect the will to work on Urban Environmental Acupuncture and on its implementation.

Next meeting - combined with the Project Steering Committee - is planned for the end of September 2020, again in a tele-mode.
