

REGIONAL IMPACT

POSITIVE LABOUR MARKET INTEGRATION ATTRIBUTES IN LJUBLJANA:

- Refugees with international and subsidiary protection have full access to the labour market.
- The Employment Service of Slovenia provides a variety of occupational courses and also includes/invites refugees.
- Networks of NGOs organize special courses for migrants covering the fundamental steps of business creation and self-employment opportunities.
- Grassroots and informal networks supply essential social spaces for inclusion and motivation.
- NGO networks offer and assist with the first-period orientation regarding the labour market and social inclusion.

KEY INTEGRATION CHALLENGES FACED BY REFUGEES IN LJUBLJANA (2015-2019)⁶

- Lack of adequate information regarding self-employment, weak labor market opportunities.
- Gender discrepancy regarding labour market access inadequate childcare possibilities.
- Understanding of the bureaucratic landscape of Ljubljana (social and labour rights).
- Educational mentoring for refugee youth, vocational trainings.
- Lack of motivation due to bureaucracy, sophisticated system of the Employment office
- Social exclusion, lack of common social space, lack of interaction with local population
- Slovene language proficiency

SIforREF examines and tests solutions with the aim to support societal and labour market integration of refugees after their arrival in five Central European cities. Our team consists of researchers, representatives of local government and actors from civil society.

To increase socio-political capabilities & access to resources for refugees


